#### From the editor ...

The main objectives for Black Studies can be easily formulated, Academic Excellence and Social Responsibility. What is the origin and history of this slogan? While the background is rooted in the role models of the intellectual activists of Black history (Frederick Douglas, W.E.B. DuBois, Paul Robeson, Martin Luther King, and Malcolm X), the context for this slogan is the search in the 1960's for a relevant Black education that would help students prepare to meet the needs of the Black community. First, Black people developed a phase of the Black liberation movement. Then, after the assasination of Malcolm X and M. L. King, new demands emerged to enroll more Blacks in higher education. Once on the inside, Black students joined with Black faculty to pursue the lofty aim of academic excellence while remaining committed to being socially responsible as part of the Black liberation movement.

Academic Excellence and Social Responsibility was first used as the theme of a conference on Black Studies held at the University of California at Santa Barbara, December, 1977, attended by over 60 schools. It was repeated at a conference at the University of Illinois (Chicago) in 1978. During 1979 it was adopted as the main theme of the Afro-American Studies and Research Program at the University of Illinois (Urbana) and for the Illinois Council for Black Studies, founded at Urbana that same year. By 1983 it had been adopted as the permanent conference theme of the National Council for Black Studies. This is an idea whose time has come.

Unity is enhanced when clarity reveals shared values and common interests. This slogan, Academic Excellence and Social Responsibility, can be a basis for the unity needed to march triumphantly into the 21st century.

Charlie Parker wrote a tune, "Now's the Time!" Maybe Bird had a point.
