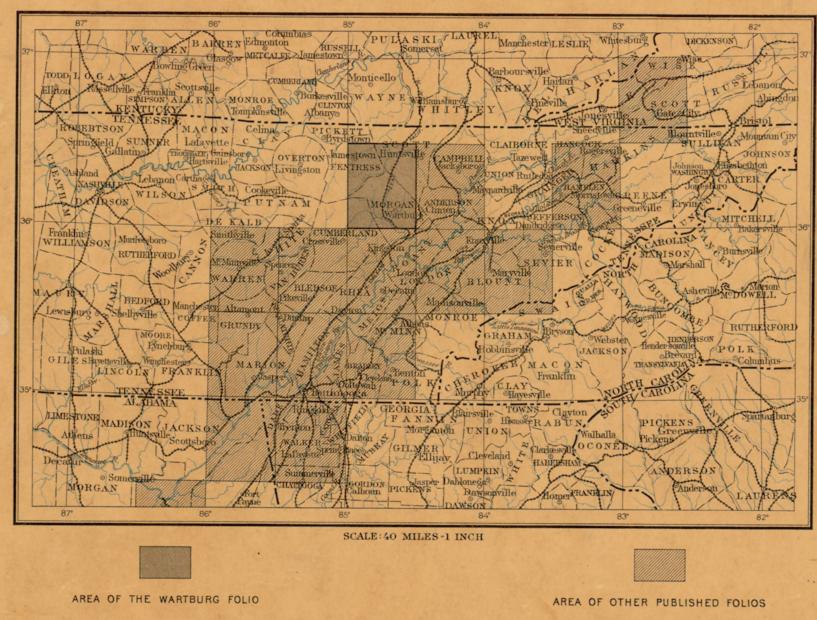

THE TOPOGRAPHIC MAP.

The features represented on the topographic map are of three distinct kinds: (1) inequalities hills, and mountains; (2) distribution of water, steep slope, and therefore contours are far apart surveys in locating roads, railways, and irrigation stone, or shale. 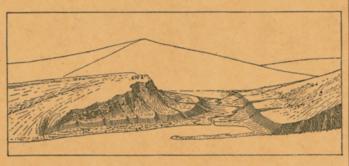




Fig. 1.—Ideal sketch and corresponding contour map.

The sketch represents a river valley between two hills. In the foreground is the sea, with a bay which is partly closed by a hooked sand-bar. On each side of the valley is a terrace. From the terrace on the right a hill rises gradually, while from that on the left the ground ascends steeply in a precipice. Contrasted with this precipice is the gentle descent of the left-hand slope. In the map each of these features is indicated, directly beneath its position in the sketch, by contours. The following explanation may make clearer the manner in which contours delineate elevation, form, and grade:

1. A contour indicates approximately a certain height above sea-level. In this illustration the contour interval is 50 feet; therefore the contours are drawn at 50, 100, 150, 200 feet, and so on, above sea-level. Along the contour at 250 feet lie all points of the surface 250 feet above sea; and similarly with any other contour. In the space between any two contours are found all elevations above the lower and below the higher contour. Thus the contour at 150 feet falls just below the edge of the terrace, while that at 200 feet lies above the terrace; therefore all points on the terrace are shown to be more than 150 but less than 200 feet above sea. The summit of the higher hill is stated to be 670 feet above sea; accordingly the contour at 650 feet surrounds it. In this illustration nearly all the contours are numbered. Culture.—The works of man, such as roads, railroads, and towns, together with boundaries of details, are printed in black.

Scales.—The area of the United States (excluding Alaska) is about 3,025,000 square miles. On a map with the scale of 1 mile to the inch this would cover 3,025,000 square inches, and to accommodate it the paper dimensions would need to be about 240 by 180 feet. Each square mile of ground surface would be represented by a square inch of map surface, and one linear mile on the ground would be represented by a linear inch on the map. This relation between distance in nature and corresponding distance on the map is called the scale of the map. In this case it is "1 mile to an inch." The scale may be expressed also by a fraction, of which the numerator is a length on the map and the denominator the corresponding length in nature expressed in the same unit Thus, as there are 63,360 inches in a mile, the scale "1 mile to an inch" is expressed by 1 63.360. Both of these methods are used on the maps of the Geological Survey.

Three scales are used on the atlas sheets of the Geological Survey; the smallest is 1 the intermediate $\frac{1}{125,000}$, and the largest $\frac{1}{62,500}$. These correspond approximately to 4 miles, 2 miles, and 1 mile on the ground to an inch on the map. On the scale \(\frac{1}{62,500}\) a square inch of map surface represents and corresponds nearly to 1 square mile; on the scale 1/125,000, to about 4 square miles; and on the scale \(\frac{1}{250,000}\), to about 16 square miles. At the bottom of each atlas sheet the scale is expressed in three different ways, one being a graduated line representing miles and parts of miles in English inches, another indicating distance in the metric system, and a third giving the fractional scale.

THE GEOLOGIC MAP.

The maps representing areal geology show by colors and conventional signs, on the topographic base map, the distribution of rock formations on mentary deposits may be separately formed, or the surface of the earth, and the structure-section map shows their underground relations, as far as known, and in such detail as the scale permits.

When the materials of which sedimentary rocks if deposited with the aid of life, it is called an organic sediment. The more important rocks formed from chemical and organic deposits are limestone, chert, gypsum, salt, iron ore, peat; lignite, and coal. Any one of the above sedithe different materials may be intermingled in many ways, producing a great variety of rocks.

Sedimentary rocks are usually made up of layers or beds which can be easily separated. These layers are called strata. Rocks deposited

DESCRIPTION OF THE WARTBURG QUADRANGLE.

GEOGRAPHY.

the Wartburg atlas sheet lies entirely in Tennessee. It is included between parallels 36° and 36° 30' and meridians 84° 30' and 85°, and it contains 963 square miles, divided equadrangle. between Scott, Morgan, Cumberland, and Fentress

In its geographic and geologic relations this quadrangle forms a part of the Appalachian province, which extends from the Atlantic coastal plain on the east to the province. the Mississippi lowlands on the west, and from central Alabama to southern New York. All parts of the region thus defined have a common history, recorded in its rocks, its geologic structure, and its topographic features. Only a part of this history can be read from an area so small as a single quadrangle; hence it it necessary to consider the individual quadrangle in its relations to the entire province.

In West Virginia and portions of Pennsylvania the plateau is sharply cut by streams, leaving in relief irregularly rounded knobs and ridges which bear but little resemblance to the original surface. The western portion of the plateau has been completely removed by erosion, and the surface is now comparatively low and level, or rolling.

Altitude of the Appalachian province.—The Appalachian province as a whole is broadly dome-shaped, its surface rising from an altitude of about 500 feet along the eastern margin to the crest of the Appalachian Mountains, and thence descending westward to about the same altitude on the Ohio and Mississippi rivers.

> Drainage of the Appalachian province.—The drainage of the province is in part eastward to the Atlantic, in part southward to the Gulf, and in part westward to the Mississippi. All of the western, or plateau, division of the province, except a small portion in Pennsylvania and another in Alabama, is drained by streams flowing westward to the Ohio. The northern portion of the eastern, or Appalachian Mountain, division is drained eastward to the Atlantic, while all of the area south of New River except the eastern slope is drained westward by tributaries of the Tennessee River or southward by tributaries of the Coosa.

AGES OF ROCKS.

Rocks are further distinguished according to their relative ages, for they were not formed all at one time, but from age to age in the earth's history. Classification by age is independent of origin; igneous, sedimentary, and surficial rocks may be of the same age.

In cliffs, canyons, shafts, and other natural and artificial cuttings, the relations of different beds to one another may be seen. Any cutting which exhibits those relations is called a section, and the the relations. The arrangement of rocks in the earth is the earth's structure, and a section exhibiting this arrangement is called a structure section.

The geologist is not limited, however, to the natural and artificial cuttings for his information concerning the earth's structure. Knowing the manner of the formation of rocks, and having traced out the relations among beds on the surface, he can infer their relative positions after they pass beneath the surface, draw sections like those of the first set, are conformable. which represent the structure of the earth to a considerable depth, and construct a diagram cutting many miles long and several thousand feet deep. This is illustrated in the following figure:

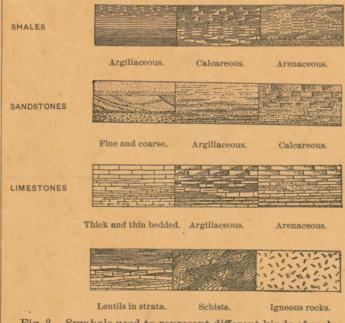


Fig. 3.—Symbols used to represent different kinds of rock.

When strata which are thus inclined are traced underground in mining, or by inference, it is frequently observed that they form troughs or arches, such as the section shows. But these sandstones, shales, and limestones were deposited beneath the sea in nearly flat sheets. That they are now bent which have from time to time caused the earth's surface to wrinkle along certain zones.

On the right of the sketch the section is composed of schists which are traversed by masses of igneous rock. The schists are much contorted and their arrangement underground can not be inferred. Hence that portion of the section delineates what is probably true but is not known by observation or well-founded inference.

In fig. 2 there are three sets of formations, distinguished by their underground relations. These sedimentary strata are now high above the sea, forming a plateau, and their change of elevation shows that a portion of the earth's mass has swelled upward from a lower to a higher level. The strata of this set are parallel, a relation which is called conformable.

> The second set of formations consists of strata which form arches and troughs. These strata were once continuous, but the crests of the arches have been removed by degradation. The beds,

The horizontal strata of the plateau rest upon the upturned, eroded edges of the beds of the exhibiting what would be seen in the side of a second set at the left of the section. The overlying deposits are, from their positions, evidently younger than the underlying formations, and the bending and degradation of the older strata must have occurred between the deposition of the older beds and the accumulation of the younger. When younger strata thus rest upon an eroded surface of older strata the relation between the two is an unconformable one, and their surface of contact is an unconformity.

The third set of formations consists of crystalline schists and igneous rocks. At some period of their history the schists were plicated by pressure and traversed by eruptions of molten rock. The section and landscape in fig. 2 are ideal, but they illustrate relations which actually occur. The sections in the structure-section sheet are related to the maps as the section in the figure is related to the landscape. The profiles of the surface in the section correspond to the actual slopes of the ground along the section line, and the depth of any mineral-producing or water-bearing stratum which appears in the section may be measured from the surface by using the scale of the map.

Columnar-section sheet.—This sheet contains a concise description of the rock formations which occur in the quadrangle. The diagrams and verbal statements form a summary of the facts relating to the character of the rocks, to the thicknesses of the formations, and to the order of accumulation of successive deposits.

The rocks are described under the correspondthe columnar diagrams by appropriate symbols. The broad belt of lower land is traversed by The thicknesses of formations are given under several ridges, which are seen in the section to the heading "Thickness in feet," in figures which state the least and greatest measurements. The average thickness of each formation is shown in the column, which is drawn to a scale-usually 1000 feet to 1 inch. The order of accumulation of the sediments is shown in the columnar arrangement: the oldest formation is placed at the bottom of the column, the youngest at the top, and igneous rocks or other formations, when present, are indicated in their proper relations.

The formations are combined into systems which correspond with the periods of geologic history. Thus the ages of the rocks are shown, and also the total thickness of each system.

The intervals of time which correspond to events of uplift and degradation and constitute and folded is regarded as proof that forces exist interruptions of deposition of sediments may be indicated graphically or by the word "unconformity," printed in the columnar section.

> Each formation shown in the columnar section is accompanied by its name, a description of its character, and its letter-symbol as used in the maps and their legends.
