E-Rate Update: FCC Seeks Comments on Proposed Changes in E-Rate; and Funding Commitment Letters Sent to Applicants for Year 1, 2 and 3 Appeals Found to be Meritorious

Two major developments have occurred with respect to the E-Rate program. The FCC posted a Notice of Proposed Rule Making on January 25 calling for comments within 45 days after publication in the <u>Federal Register</u> on numerous proposed changes which could provide increased opportunities for TechMIS subscribers that have E-Rate eligible products and services, as well as those with non-eligible products. The proposed changes represent an attempt to streamline the program, ensure fair and equitable distribution of funds, and protect applicants from fraud and abuse.

Several changes relate to "eligible services." Currently, informal inquiries as to whether a particular product is eligible can be made with limited guidance. On the other hand, an appeal can be made only after a requested service in question is rejected because of ineligibility. This problem has been addressed in many of the biweekly Wednesday service provider conference calls. One possible alternative approach suggested in the proposed rule making would be to establish a computerized list, which is accessible online, through which applicants could select a specific product or service as part of their FCC Form 471 application. While this could reduce the number of rejections, it could also limit applicants' ability to take advantage of newly introduced products and services which could be eligible.

The FCC is also seeking comments regarding eligibility policies related to WANs, wireless service, and voice mail. Comments are also sought related to other eligibility issues such as: permitting schools and libraries to receive discounts for Internet access that may, in certain limited cases,

contain content, as long as it is the most cost-effective form of Internet access; and whether to require schools and libraries certify their compliance with the requirements of the Americans with Disability Act and related statutes such as Section 508. Attempts under the Clinton Administration to require such assurances related to compliance of Section 508 that all technology purchases (including software), be accessible to individuals with disabilities, were sternly rejected. By including this new ADA certification requirement, the FCC would be acting consistently with this Administration's New Freedom Initiative, which could be good for certain assistive technology sales. Specifically, the FCC would like those commenting to "propose language" for any ADA certification and suggest an effective date of this certification requirement.

Under current procedures, service providers and applicants are advised to determine jointly whether the applicant will either: (a) pay the service provider the full cost of the service and subsequently receive reimbursement from the provider for the discounted portion after the provider receives reimbursement on the BEAR form; or (b) pay only the nondiscounted portion of the cost of service. Noting that some large providers require recipients to use the BEAR form, the FCC is interested in receiving comments on, for example, whether a determination should be at the sole discretion of the applicant. It is also seeking comment on whether the ten-day limit on service provider reimbursement of discount amounts should be extended to 20 days. The existence of the BEAR process beginning in August 1998 has resulted in between \$4-\$5 billion being leveraged through E-Rate generated refunds to purchase ineligible products and services such as computers, software, and even staff development. While the BEAR process has, in some cases, created some administrative problems for both applicants and eligible service providers it has certainly been a major source for purchases of instructional software.

Last, among other items, the FCC is seeking comments on how it should treat unused funds such as automatically carrying over unspent funds one year to the next year, on top of the \$2.25 billion cap.

As an example of the opportunities available through the current BEAR process, the USAC recently posted, on its website, districts which have received Funding Commitment Letters indicating their appeals had been found to be "meritorious" or "out-of-the-window" applications had been approved.

Some of these new authorizations and funding commitments concerned appeals in Year 1 and Year 2. However, the vast majority (recently posted in the USAC fourth quarter report) were funding commitments and authorizations for Year 3. Enclosed as Attachment A is an updated listing (similar to the previous list in the December Special Alert which is also included as Attachment B) of districts receiving authorizations and funding commitments of at least \$100,000; these districts very likely will be requesting refunds under the BEAR process, which in turn can be used to purchase software, training, and other non-eligible products and services (see suggestions in the Attachment A). SLD Begins to Send Funding Commitment Letters to Applicants Which Were Found to be Meritorious Appeals for Funding Years 1-3 and Out-of-the-Window Applicants Which Could Provide Opportunities for Vendors of Non-E-Rate Eligible Products and Services Where the BEAR Process Will be Used by Applicants

Several hundred million dollars are in the process of being allocated to E-Rate applicants which have been notified by Funding Commitment Letters that their appeals from previous Funding Years 1-3 and "out-of-the-window" applications have been approved. Many of these districts and library applicants will have already purchased the eligible E-Rate products and services paying the prediscount price; hence, most will likely use the BEAR process (i.e. completing Form 472) and request that they receive checks rather than credits for the discount amounts. If they do so, they have the flexibility to purchase non-E-Rate eligible products and services -- such as computers to be used by teachers and students, software, technology-related staff development or other technology services -- or they may use the dollars to purchase other items or to return the dollars to the school districts general fund.

The best way to qualify a district is to gather information or answers to the following questions.

1. What office at the district level is responsible for E-Rate applications and is most likely to receive the Funding Commitment Letters?

The probability is greater that such funds will be used for some software, staff development, etc., if that office is the district instructional technology office; a lower probability, if that office is the district-level IT or management information systems office; and even less, if that office is responsible for building renovation and construction.

2. If the BEAR process is used and the applicant wishes to receive a check for the discounted amount, for what will these funds be used to purchase?

As noted three years ago in a TechMIS special report on E-Rate, finding answers to this question without raising political sensitivities is no mean task. One good approach is, if a potential customer

wishes a vendor's product, have that school staff person (e.g., a principal, reading specialist, etc.) contact the E-Rate office and obtain such information. Principals can be very effective in arguing that the poverty rate in their schools was a major factor in determining the amount of refund the district received and that the principal/school should receive a portion of those funds.

For the first time, the SLD, which administers the E-Rate program, is making enough information public so that we have been able to combine searches of several SLD data sets to identify districts and other applicants which, since October 1, have been receiving Funding Commitment Letters for appeals which have been found to be "meritorious." Attached is a list of districts which have been sent, over the last two months, Funding Commitment Letters for \$100,000 or more which are likely to be allocated shortly. If the applicant has already purchased the product at the full price and will be requesting BEAR refunds, then this district could be a ripe candidate.
