Hutchison, Director, College Station, Texas Helping Texas' county officials become more effective public servants is the task of the V. G. Young Institute of County Government. This pioneer program, known as the County Officials Program, operates as a part of the Texas Agricultural Extension Service of the Texas A&M University System. The Institute was named in honor of the late V. G. Young, who in his capacity as Assistant Director of the Texas Agricultural Extension Service, established in 1956 the first regular program of informal education for the leaders of Texas' county governments.

Regular activities of the County Officials Program include sponsorship of statewide and regional conferences and development of publications of current interest, together with personal and individual assistance to Texas' county officials.

Annually, on the campus of Texas A&M University, county officials from all sections of the state meet for two days to discuss topics of primary importance to the functions of their respective offices. In recent years programs have been held for county judges and commissioners, county and district clerks and county treasurers.

Staff members of the County Officials Program work closely with elected officers of the various associations of county officials in planning and presenting conference programs that are both relevant and enlightening. Featured speakers include outstanding leaders in Texas government, the academic world and private industry.

Many Texas counties have hosted regional Institute workshops, seminars and other training programs. The success of these educational endeavors at the regional level clearly indicates the importance of the continued availability of training of this type in various localities throughout Texas.

Maintaining a flow of usable publications is a major educational goal of the County Officials Program. Bound copies of conference proceedings, periodic newsletters and a variety of pamphlets have been provided to help officials better inform themselves and the public concerning their role in local government. Certain popular publications also are available in Spanish translation to help officials better inform their Spanish speaking constituents.
