The applicant doesn't own property in Shankleville but has researched & planned symposia w/community members since 2014. They have two cemeteries. Jim Shankle Cemetery, named for the community founder, is where he & descendants are interred. Shankleville Community Cemetery is across the street (FM1415) from the Shankle Cemetery. Shankleville's support letter approving this Project is attached.

Shankleville descendants founded satellite freedom colonies creating an enduring mutual aid system supporting cemetery preservation for several settlements. During the plan development & survey instrument testing, the Consultant & project lead will work w/Shankleville Community's network in Newton County. Shanklievlle includes the Addie & A.T. Odom Homestead listed on the National Register of Historic Places in 2012. Additionally, state historical markers recognize the cemeteries, Stephen McBride who founded McBride College in Shankleville. State historical markers also recognize the following freedom colony sites in Newton and Jasper Counties: Springhill Cemetery - Big Joe Turner Gravesite, Biloxi Settlement, Cedar Grove Community, Dixie Community. However, several don't have historical markers. The survey of area settlements & cemeteries should provide opportunities to possibly list more sites with Reconstruction Era significance as part of a rural district or as individual sites.

#### **Site Significance**

Cemeteries & freedom colonies to be identified, mapped, & assessed are associated with historic black settlements founded 1865-1920 in Newton County. Several freedom colonies were founded by families originating in Shankleville. The cemeteries are across from the Odom Homestead (listed on the National Register of Historic Places) built by AT Odom in 1922. Odom's great-grandfather was community founder, Jim Shankle. The Odoms made significant contributions to Shankleville during the Jim Crow era.

#### **Current Use**

Cemeteries are in use in Newton County, including the historic Shankleville cemetery in which the community founders, formerly enslaved Jim (b. 1811) & Winnie Shankle (b. 1814), are interred (See the story of Shankleville here: https://youtu.be/xCDjTek8cvo). Formerly enslaved freedom colony founders are buried in cemeteries throughout Newton & Jasper counties (see map uploaded with photos). All cemeteries serve descendants & extended family members of founders, educators, & religious leaders.

# **Historic Features**

Cemeteries are still in use & reflect African Diaspora burial traditions spanning the late 1800s to the present. Nearby churches have been modified over time but the AT Odom Homestead remains. In addition to building the homestead, A.T. Odom (b.1893) also kept the cemetery records & was the custodian of the burial tools. Predating churches are landscape features (trees) which once formed the brush arbors near present-day Shankleville's cemeteries, bridging Pre-Emancipation & Reconstruction eras.

The project goal is to produce a strategic & technical project plan for The Texas Freedom Colonies Project's Atlas & Survey (TXFCP) platform. Freedom colonies, historic African American settlements founded 1865-1920 in Texas, are most recognizable by landscape elements-cemeteries, homesteads, churches, &schools. Today, natural disasters, gentrification, & sprawl threaten freedom colonies' cultural assets. The Project lead's previous work in Newton & Jasper counties revealed that atrisk place & cultural asset location knowledge are embedded in oral histories. An organized approach to crowdsourcing, recording, storing, & analyzing aging descendants' memories of freedom colonies & cemetery locations & ways to contact constituencies is needed urgently. The TXFCP Atlas & Study has hosted an interactive public map & survey since July 12, 2018. However, the accompanying website & ArcGIS map (http://www.thetexasfreedomcoloniesproject.com/) requires an integrated engagement & cultural resource survey system plan. Focusing on cemetery preservation presents the opportunity to identify, map & store data about cemeteries, which are proxies for freedom colonies. However, the scope is large. According to Texas County Historical Commission reports, on average, 1/3 of cemeteries per county have no stewards. Family members/cemetery associations request assistance from county historical commissions (CHC) to locate unmarked graves & secure maintenance. Unfortunately, CHCs often lack the cultural competencies required to work effectively with freedom colony cemetery stewards. To date, The TXFC Project along has located 357 of the 557 known settlements, frequently by their association with annual cemeterv fundraisers & storytelling events. However, several peer cemeteries go unrecorded & unmaintained. Similarly, at least 200+ settlements containing cemeteries are going unmapped. In addition, the current web-mapping platform lacks the capacity to assess cemeteries' conditions in the field. The Plan would provide guidance on "retrofitting" the current Atlas's survey & storytelling functions to accommodate integrated identification, mobile assessment, intake, & referral functions. The Consultant will determine if open source/free software such as the Arches Collector Model which uploads survey data from the field (https://arches.readthedocs.io/en/latest/usingarches-collector/) should be integrated into the current web mapping platform. Project survey design, assessment materials, & outreach will reflect the Secretary of the Interior's Standards for the Treatment of Historic Properties by recommending that communities: Identify & inventory all features, materials, spaces, & spatial relationships that define a cemetery's historic character & integrity; Recognize the significance of changes over time as evidence of the history & development of the cemetery; Repair, rather than replace, deteriorated cemetery features when feasible using best practices for cleaning surfaces & maintenance

(https://cemeteryconservatorsunitedstandards.org/standards/); and Protect & preserve unmarked graves. A detailed Plan will allow processing & spatializing of data (oral histories, photos) enabling mapping of previously unknown co-located communities & cemeteries. The Plan's engagement section will lay the foundation for bringing promising practices embedded in existing networks up to scale. Project products include the comprehensive Plan & assessment forms. This Plan will describe the capacity & technological requirements to detect & record cemeteries in the Atlas while in the field. Technologies considered include ground-penetrating radar for mapping & sinkhole & void detection. All Project Plan development involves freedom colony descendant engagement. The Texas A&M Center for Heritage Conservation, Center for Digital Humanities Research, & the Center for Housing & Urban Development faculty, fellows, & Ph.D. students will work closely with the hired consultants.

#### **Overall Scope of Work**

Grant funding will support a consultant's travel, consultation with experts & materials associated with onsite planning with communities & research on mobile survey & assessment applications development. The geographical scope includes known (35) settlements & their cemeteries in Newton & Jasper counties with an initial focus on Shankleville Community. The Consultant will work with a homecoming celebration network, which cooperatively fundraises for local graveyard stewardship. The consultant will coordinate plan development and test some aspects of the Plan's efficacy. Funding isn't requested for the Texas A&M College of Law Clinic, which will address compliance with preservation, real estate, & intellectual property law. Survey and data processing is also supported by a consortium of knowledge management partners, which will include archivists from TAMU Cushing Library's Texana Collection, Prairie View A&M University, and The African American Library at the Gregory School in Houston.

The Plan is intended to create a foundation for platforms, research, & engagement strategies for use by not only grassroots preservationists & professionals in Texas, but in other states. Notably, The TXFC Project method focuses on African American social networks, which have been proven to sustain descendants' attachment & commitment to place preservation. Stories & social networks associated w/annual homecomings, heritage festivals, & reunions are the vehicles through which cooperative cemetery maintenance & fundraising is conducted. Similarly, the African American Burial Grounds Network Act requires engaged cemetery preservation, which leverages social capital embedded in such networks. The goals of the Act are consistent with that of the proposed grant project. For example, both the Act & this proposal support working w/ state, local, & non-profit groups, "educating the public and providing technical assistance for community members... to research, survey, identify, record, and preserve burial sites and cemeteries within the Network." Like the Act, the Project Plan will articulate ways the Atlas can support participation in a voluntary database of burial grounds detected during surveys of freedom colony cultural resources, provision of technical assistance related to assessment, and increase access to educational materials to descendant communities. The Plan will address ways to capture & aggregate data within existing local networks, which will support the Act's aims.

#### **Financial Sustainability**

The project lead will pursue TAMU & external grant funding. Since the project began, the founder has amassed \$45,000 in grant & internal research funds including \$10,000 Program to Enhance Scholarly, & Creative Activities (PESCA) grant that funded the research assistant who built the Atlas & Survey (http://bit.ly/txfcpatlastwo). Other grants being pursued include Andrew W. Mellon Foundation (\$100,000), The NEH Digital Humanities Advancement Grant (\$100,000) & the Whiting Fellowship (\$50,000).

The \$75,000 budget funds materials (6,500), equipment (recorders, software, wifi hotspots, cameras, cemetery evaluation tools) (13,625), professional services (40,876), & travel (6,500) needed for onsite tool & instrument testing. Professional services fund the consultant who develops the tools & plan. The balance covers indirect cost requirements.

Since 2014, the SHS has hosted the symposium on freedom colony heritage & K-12 history education. They also provide access to their cemeteries.

Texas Historical Commission-Certified Local Government Program will co-host workshops on cemetery preservation allow presentations at meetings with county historical commissions to promote the use of the freedom colony mapping tool. Council of Texas Archeologists will share access to radar and other equipment & help incorporate cemetery preservation evaluation questions into the Atlas

African American Library at the Gregory School: The Houston library provides meeting space & archival staff

Texas 10 Historical Explorers, will share their experiences engaging in grassroots cemetery preservation.



Dr. Roberts' work intersects my professional life in two ways. I am the Group Manager for Natural and Cultural Resources for Terracon's Houston, TX office. I also serve as the President of the statewide association of professional archeologists, an organization called the Council of Texas Archeologists. In our office, we have adopted Dr. Roberts' Atlas as an additional layer of information that we make use of when evaluating (on a client's behalf) parcels of land within the state of Texas that may be developed. These so-called Desktop Assessments are a valuable consulting tool that can help project owners and sponsors understand the known or probable Cultural Resource issues or risks associated with any given project. The Freedom Colony Atlas is a vital tool, in our opinion, for helping raise awareness of, and thereby afford protection to, "at-risk" sites that are commonly unrecorded, poorly understood, and/or under-appreciated in our industry. As President of the CTA, over the last year I have worked to bring awareness to our members of Dr. Roberts work. Her ongoing research into Freedom Colonies is probably the best current example of the potential for positive impact that multi-disciplinary work can have on archeological sites and our professional practices.
