Contributor Biographies

- Anne Applebaum is a columnist for the Washington Post and a Pulitzer-Prize winning historian. She is an adjunct fellow of the Center for European Policy analysis. Formerly a Member of the Washington Post editorial board, she has also worked as the Foreign and Deputy Editor of the Spectator magazine in London, as a columnist at Slate and at several British newspapers, including the Daily and Sunday telegraphs. From 1988-1991 she covered the collapse of communism as the Warsaw correspondent of the Economist magazine and the Independent newspaper. Chapter Title: "Putin's Grand Strategy"
- **Pascal Bruckner** is a world renowned essayist and novelist whose works have been translated in thirty countries. He has taught for fifteen years at the Institude d'Etudes Politiques in Paris and has been a visiting professor at New York University and at San Diego University. Dr. Corum is the author of eight military history books, including: The *Roots of Blitzkrieg* (1992), The Luftwaffe: Creating the Operational War (1997), The Luftwaffe's Way of War, with Richard Muller (1998), Airpower in Small Wars, with Wray Johnson (2003), Quelling the Beast: A Counterinsurgency Strategy for America (2006), Fighting the War on Terror: A Counterinsurgency Strategy, with Michael Howard (2007), Wolfram von Richthofen: Master of the German Air War (2008), Bad Strategies: How Major Powers Fail in Counterinsurgency, with Dennis Showalter (2008), and Training Indigenous Forces in Counterinsurgency: A Tale of Two Insurgencies (2014). He has authored a number of book chapters and journal articles on military history and counterinsurgency. He holds an M.A. from Brown University, M. Lit. - Lynn D. Corum is a professional translator. Chapter Title: "Project Russia: The Bestselling Book Series of Putin's Kremlin"
- Nicholas Eberstadt, a political economist and demographer by training, is a Henry Wendt Scholar in Political Economy at the American Enterprise Institute. In addition to his role with AEI, Eberstadt serves as a senior adviser to the National Bureau of Asian Research, a member of the visiting committee at the Harvard School of Public

Health, and a member of the Global Leadership Council at the World Economic Forum. He researches and writes extensively on economic development, foreign aid, global health, demographics, and poverty. He is the author of numerous monographs and articles on North and South Korea, East Asia, and countries of the former Soviet Union. His books range from *The End of North Korea* (AEI Press, 1999) to *The Poverty of the Poverty Rate* (AEI Press, 2008). - **Ray C. Finch** is a Eurasian Military Analyst for the Foreign Military Studies Office at Fort Leavenworth and retired Eurasian Foreign Area Officer with the U.S. Army. Gregory has also published The Global Economy and Its Economic Systems (Cengage, 2013) and is working with director Marianna Yarovskaya on a film documentary entitled Women of the Gulag. - Serhii Plokhii is the Mykhailo Hrushevsky Professor of Ukrainian History at Harvard and the director of the university's Ukrainian Research Institute. A leading authority on Eastern Europe, he has lived and taught in Ukraine, Canada and the United States.

- **Roger Reese** is a Professor of History at Texas A&M University specializing in Soviet social history in general and the social history of the Soviet military in particular. In December 2013, he was barred from returning to Russia, earning the dubious distinction as the first American journalist banned from Russia since the end of the Cold War. - Andreas Weise is RIAS Berlin Fellow and German journalist. Born in East Germany, Weise lived under a communist regime until his 20th birthday.
