


Real Gross Domestic Product

United States Nonfarm Employment






Real Taxable Sale in Texas




College Station-Bryan Business-Cycle Index


College Station-Bryan Business-Cycle


Unemployment Rates in College Station-Bryan, Texas, and the United States

Unemployment Rates in Texas MSAs – June 2021




The local unemployment rate was the third lowest among the Texas MSAs in June and has been one of the lowest rates each month of the recovery.

Nonfarm Employment and Real Taxable Sale in College Station-Bryan MSA




Components of Population Growth in College Station-Bryan MSA, 2010-2019


Non-migrant and Migrant Incomes in Brazos County and Nationally






Taking Stock

- National
 - Real GDP and Personal Consumption expenditures have exceeded their levels at the peak of the previous business-cycle.
 - Nonfarm employment as of July was 4% below the previous peak.
- State
 - Real taxable sales in June were 8% above their level in February 2020.
 - State tax collections though July of this fiscal year have exceeded the collection for the same period of the previous fiscal year and are 98% of the collections from FY 2019.
 - Nonfarm employment in June was 97% of February 2020's level.
- Local
 - Real taxable sales in June were the same as in February 2020.
 - Nonfarm employment in June was 3% below the February 2020 level.
 - The number of travelers out of Easterwood Airport in July was about the same as the number of travelers in July of 2019.


Brazos County Active Cases and Hospitalizations


Harris County Active Cases and Hospitalizations


Travis County Active Cases and Hospitalizations

What is next?

- The national, state and local economies continue to rebound from the Covid Recession.
- Continuing the pace of the recovery requires reducing the current uncertainty brought about by the rise in Covid cases and hospitalizations.
- Forecast seem to be for Q3 Real GDP to be up about 1.5% (or and increase of 6% calculated as a seasonally adjusted annual rate), further cementing the recovery in GDP.
- The labor market has further to go, and forecasts suggest full recovery might not occur until near the end of 2022.
- Surging Covid-19 infections pose some risk, as does surging inflation rates and what will probably be rising interest rates.
