## President's Column

It's hard to believe my term as GISIS president is already coming to a close. It has been a great year, and I have really enjoyed working with all of you. Looking back, I wanted to recap a few of the changes we made over the past year.

I have to admit; when I first began this position I had some concerns. Membership had been waning for a number of years, down to less than half of what it was in the early 2000s. We had also determined that the GISIS bylaws were out of date, referring to snail mail procedures that had long since been abandoned. More importantly, former GISIS Treasurer Carolyn Bishoff had discovered a problem with the Society's D.C. incorporation status that dated all the way back to 1974.

But there was much to be excited about too. After all, the Society was entering its 50<sup>th</sup> anniversary year, which was sure to help boost membership and awareness, and we still had a great group of active members. With that in mind, we got to work.

As noted in the March Newsletter, we solved the D.C. incorporation problem thanks to significant pro bono help from Graham Green and Dennis Allen of Sutherland Asbill & Brennan LLP. Thanks to a brief amnesty window, the Society avoided significant penalty fees and is now up to date with D.C. for the first time since the 1970s. Shaun Hardy also deserves thanks for acting as GISIS's registered agent in D.C.

One of the things that became apparent during the incorporation discussion was that we needed some stable GISIS addresses so that these types of important filing requirements couldn't get lost. This led to creating @geoinfo.org e-mail addresses for the main Executive Board positions, such as president@geoinfo.org and vp@geoinfo.org. These free addresses are now in place and give incoming board members access to relevant e-mail histories as well as shareable documents for tracking membership and the like. Thanks for this project go to GISIS's webmaster, Courtney Hoffner, and

AGI's Chris Keane (AGI hosts the GSIS site). Side note: Courtney was also able to install Google Analytics on our website, meaning that we're now tracking information that will be helpful in future membership campaigns.

Next, we got to work overhauling some of the membership procedures. Years ago it may have been a fairly straightforward process to keep track of membership. Now with digital payments, this can often be a puzzle, with some members never submitting contact information and other payments being made under different billing names and addresses. Membership Committee Chair Cynthia Prosser led a campaign to correct this. We now have an online form that immediately captures and shares this information with the treasurer and secretary. Thank you Cynthia and Louise for their work on this.

Related, one of the items that came out of the incorporation discussions with the lawyers was that GSIS had begun to stockpile too much money. As a nonprofit, we were supposed to run at a break-even level. Our frugality, and perhaps larger than expected revenue from the Vendor Updates, meant that we had been running well into the black for many years. To address this, and to help stimulate an increase in membership, the Membership Committee recommended a reduction in dues. This will be voted on at the Business Meeting later this month. Even without the change in dues, I'm happy to report that the membership number is already higher than last year.

Later this month we will also vote on the proposed bylaws changes. Dena Fracolli Hanson chaired this committee with a goal of simplifying things and updating them to reflect our current digital procedures. Hard copies of these proposed changes were mailed out to all members in late July. Special thanks also go to Anne Huber, for unearthing numerous other versions of the bylaws from the GSIS archives.

With the heavy lifting of the incorporation, membership, and bylaws out of the way, it was time to focus on something fun: the 50<sup>th</sup> anniversary. The plan had long been to convert the awards luncheon into a fancier dinner, but soon word spread that there had been a keynote speaker at the 25th anniversary. We set about replicating this for the 50<sup>th</sup> and asked G. Salim Mohammed, the head and curator of the new David Rumsey Map Center at Stanford University. In addition to Salim's presentation, which I am very excited about, there will also be small gifts as well as a number of other historical retrospectives that Shaun Hardy is putting together. Thanks to the whole Ad Hoc 50<sup>th</sup> Anniversary Celebration Committee for their help with this.

There are other areas where change is ongoing. The Executive Board voted in July to eliminate the six month embargo that had been (somewhat) in place on the Proceedings and Newsletters. The Board determined that free access to the publications will expose the valuable content to nonmembers, potentially making them more interested in GSIS membership. Furthermore, if the Society encourages open access publishing elsewhere, the Board agreed that GSIS ought to follow the same standards. While there was some concern that this may be viewed as a decrease in the value of membership, it was noted that the real member benefit is the ability to contribute to the newsletter, not just read it.

Another discussion item that will be continued at the business meeting is the potential elimination of the publications manager executive board position. This change was recommended by the current publications manager, Richard Huffine, who views the position as redundant now that GSIS is no longer producing a printed Proceedings. As part of this change, Richard will be distributing the remaining print inventory of proceedings via Geonet. More news on this to follow.

Looking back, it has been a pretty good year. I am really impressed, and thankful for, the significant help I received from many GSIS members. There are also many other exciting projects that I was not involved in, such as Hannah and Bob's mentorship program. I also want to note that GSIS Treasurer Lori Tschirhart overcame some rather steep challenges in order to update the Society's financial information.

There are still some areas where we didn't make the progress I had hoped, such as with

## **Mary B. Ansari Distinguished Service Award**

Shaun Hardy Named 2016 Mary B. Ansari Distinguished Service Award Recipient

Shaun Hardy, librarian at the Carnegie Institution for Science, Department of Terrestrial Magnetism and Geophysical Laboratory, is the recipient of the 2016 Mary B. Ansari Distinguished Service Award from the Geoscience Information Society (GSIS). GSIS is an international professional organization devoted to improving the exchange of information in the geosciences through cooperation among scientists, librarians, editors, cartographers, educators, and information professionals.

Shaun joined the Geophysical Laboratory Library of the Carnegie Institution of Washington as its librarian in 1989. He directs all operations for the 40,000-volume library supporting advanced research in the earth and space sciences. In 2012 the Carnegie Institution presented him the Service to Science Award.

Shaun is highly regarded in GSIS for his willingness to step in when help is needed. Letters in support of his nomination emphasized his supportive and collegial nature. One letter said, “He is the epitome of the engaged professional—serving the GSIS as an officer and committee member, the broader geoscience community via his service on the GeoRef Advisory Board, and sharing his expertise with his colleagues in an upbeat, always supportive manner.” Another letter stated, “His service to GSIS and other professional societies, his outstanding work at Carnegie, his publication record, and his support of individuals in the profession are all notable.”

Shaun joined GSIS in 1994. He served the society as secretary in 1999-2000, as acting treasurer in 2001, and as publicity officer from 2005-2010 and 2013 to present. He currently serves on the Ad Hoc Committee for the GSIS 50<sup>th</sup> Anniversary Celebration. For fourteen years he has been a member of the GeoRef Advisory Committee of the American Geosciences Institute. In addition to his service

in GSIS, he is also a member of the Physics-Astronomy-Math Division of the Special Libraries Association, the American Geophysical Union, and DC Science Librarians.

Shaun has developed a passion for open access and has shared it with his profession. His paper "Open Access Publishing in the Geosciences: Case Study of the Deep Carbon Observatory," published in the *GSIS Proceedings* v. 43, 2012, p. 73-81, won the 2014 GSIS Best Paper Award.

Shaun graduated *summa cum laude* with a B.S. degree in geological sciences and physics from the University of Rochester. He received an M.L.S. degree from the School of Information and Library Studies at the State University of New York at Buffalo. He previously was chief librarian for the Buffalo Society of Natural Sciences, Buffalo Museum of Science.

# GSIS Best Paper Award and Committee Report

The GSIS Best Paper Award Committee chose the following paper by Leslie Hsu, Raleigh L. Martin, Brandon McElroy, Kimberly Litwin-Miller and Wonsuck Kim for the 2016 Best Paper Award:

**“Data management, sharing, and reuse in experimental geomorphology: Challenges, strategies, and scientific opportunities.”** This article was published in *Geomorphology*, Volume 244, 1 September 2015, 23 p., DOI: 10.1016/j.geomorph.2015.03.039. (Accessible from Elsevier ScienceDirect)

The lead author, Leslie Hsu, was at Columbia University when the article was published. Now she is the coordinator of the Community for Data Integration (CDI) at the US Geological Survey. Raleigh Martin is at UCLA, and Brandon McElroy is at the University of Wyoming. Kimberley Litwin-Miller and Wonsuck Kim are at the Jackson School of Geosciences at UT-Austin.

Many scientific fields have seen vast amounts of data produced in recent decades. Finding and accessing data has become a critical dimension of research. This paper addresses data management, access, and reuse with a focus on experimental geomorphology. The team covers the needs and challenges of data

management in ways applicable to many sciences. The authors propose guidelines and suggestions, address incentives and training, and discuss the importance of data management across the entire data life cycle. The authors bolster their work with a thorough review of the literature, including both research in their scientific field and research in the library and data science literature.

Dr. Hsu will accept the award at the 50<sup>th</sup> Anniversary celebration.

The 2015 GSIS Best Paper Committee members are: Samantha Teplitsky, Robert Tolliver, Carl Olson, and Michael Noga, chair. The committee reviewed and rated journal articles published in 2015 that were found through extensive searches of a dozen databases. The final selection was based on the top ranked paper using the following criteria: significance, originality, communication effectiveness, scholarship and contribution to the profession.

The committee read almost 20 papers to choose the award winner. The pool was unusual because there was not GSIS Proceedings for the award year. Most of the eligible papers came from the scientific literature.

## New Geoscience Open Access Publications & OA News



*Geofluids* is one of nine Wiley subscription journals converting to open access in January 2017 under a “new pilot partnership” with Hindawi.

According to a joint



announcement, Wiley will retain ownership of the journal, but Hindawi will take over responsibilities for its editing, production, and hosting on their online platform. *Geofluids* publishes “original research into the role of fluids in mineralogical, chemical, and structural evolution of the Earth's crust.” Launched by Blackwell Science in 2001, the journal moved to online-only publication in 2010. The new publishing arrangement may be good news for authors – under Hindawi, authors will pay an article processing charge of \$1,500 versus Wiley’s \$3,000 fee for their elective OnlineOpen OA program. Pre-2017 content and backfiles will continue to be accessible on

the Wiley Online Library.

On August 11, AGU announced the launch of a new, open access, peer-reviewed journal focusing on “the intersection of Earth and environmental sciences with human, agricultural, and environmental health.” Like AGU’s other scientific journals, *GeoHealth* will be jointly published with Wiley and will be part of the Wiley Online Library. The journal will begin accepting submissions this fall. Publishing charges will be waived through the end of 2016; thereafter, authors will be charged an as yet unspecified fee that will be “competitive with those of other broad open access journals.” Articles in *GeoHealth* will be published under a Creative Commons Attribution license. Rita Colwell, former Director of the National Science Foundation, will serve as the journal’s founding editor.
